

SPONSOR A KENNEL OR CAT PEN SCHEME

Holly Hedge is pleased to announce that it is now possible to sponsor either a kennel or cat pen – this was felt to be a better Scheme than sponsoring an individual dog or cat, as sometimes the animals are only with us for days before they are happily re-homed – by sponsoring a kennel/cat pen you are helping many animals throughout the year.

You will receive a **Gift Pack** (this can be for a nominated person other than yourself – it makes a fabulous present for someone who is an animal lover!) which will include:

- Personalised Sponsorship Certificate, including a picture of the animal presently residing in the kennel/cat pen you choose to sponsor.
- Pin badge of a dog/cat depending on which you sponsor.
- Holly Hedge Newsletter sent to you twice a year.
- Your name (or nominated person) will be displayed at Holly Hedge as an official sponsor (initially this will be in a “book format” but when our new kennel block is built will be wall mounted) and will also appear on the Sponsors page of the Holly Hedge website.
- You can view the present occupier of your sponsored unit by visiting the virtual sanctuary on our website.
- You are welcome to visit Holly Hedge at any time during our opening hours to see for yourself what your sponsorship is helping us to achieve.

What your Gift will provide

Your generosity will mean that Holly Hedge can continue caring for the animals in need of our help. On average we rehome 650 animals a year and amongst the cost for each animal are the following:

- £5 per month to provide Flea and Worm treatment for one dog or cat.
- £10 per month to provide vaccinations for one dog or cat.
- £30 (or more!) per month to feed one dog or cat.
- Average £120 for dogs and £60 for cats to be neutered – the list is endless!

Cost is **£5.00** per month per kennel/cat pen, or **£250** for life sponsorship. Corporate sponsorship for businesses is also available at **£500** per annum.

You can, of course, sponsor more than one unit.

Once you have decided to help us, all you need to do is to complete the attached form and return it to Holly Hedge. For lifetime membership for individuals please forward a cheque payable to Holly Hedge for the appropriate amount and **do not** complete the Standing Order Form, but please **do** sign the Gift Aid Section.

You will be giving injured, abused and abandoned animals a second chance of life and the opportunity to find the loving home they deserve and help Holly Hedge to go on caring for these animals and also plan for the future. Many thanks from everyone at Holly Hedge – both two legged and four legged; your support is much appreciated by everyone and will ensure the future of the Sanctuary.

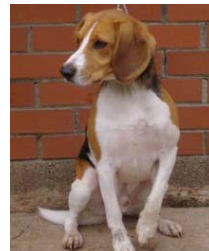
